13. Discussion / Action regarding fire lane blockage issues at the General Store (continued from 2-14 meeting) City Manager Richard Shoemaker was present to discuss this problem with the Chief and the Board. He acknowledged that the original permit required that the owner provide a striped and posted 10-foot public access way / fire lane on the north side of the General Store running from Center Street to Main Street that would remain open, unblocked, and available for emergency vehicle and public access, but that the owner had never complied with that condition. Mr. Shoemaker said that he had a Code Enforcement Consultant coming on board next week, and that this issue is the first item he will tackle. Mr. Shoemaker asked that the District send him a letter with specifications for the emergency access striping and he would ensure that the situation is corrected. [Note: The letter was sent on March 31]

The Chief and Board asked about the possibility of issuing parking citations to vehicles illegally parked. Mr. Shoemaker said he would take that up with law enforcement as a separate issue.
